Should walk the talk, says EAM to West on democracy

● ‘West should embrace successful models outside it’

Munich, February 15

EXTERNAL AFFAIRS MINISTER S Jaishankar took a dig at the Western countries for treating democracy as a “Western characteristic”, accusing them of not practising abroad what they value at home.

Jaishankar made these remarks at a panel discussion titled “Live to Vote Another Day: Fortifying Democratic Resilience” at the Munich Security Conference. He also said that “if you do want democracy eventually to prevail, it’s important the West also embraces successful models (of democracy) outside the West.” “There was a time — I have to say this in all honesty — when the West treated democracy as a Western characteristic and was busy encouraging non-democratic forces in the Global South. It still does. Everything

you value at home, you don’t practice abroad. So, I do think the rest of the Global South will view the successes, shortcomings and the responses of other countries,” he said.

He also said India, for “all the challenges that we have had, even at a low income, we have stayed true to the democratic model, which is almost if you look at our part of the world, we are pretty much the only country that has done that. So I think it’s something the West should look at, because if you do want democracy eventually to prevail,

it’s important the West also embraces successful models outside the West,” Jaishankar said. He posted on X, “Highlighted India as a democracy that delivers. Differed with the prevailing political pessimism. Spoke my mind on foreign interference.” Apart from Jaishankar, the panel comprised Norway’s PM Jonas Gahr Store, US senator Elissa Slotkin and Warsaw mayor Rafal Trzaskowski. He also said that India gives nutrition support to 800 million people thus countering US senator Elissa Slotkin’s re-

mark that democracy “doesn’t put food on the table”. “Senator, you said that democracy doesn’t put food on your table. Actually, in my part of the world, it does. Today, since we are a democratic society, we give nutrition support, and food to 800 million people. That is a matter of how healthy they are and how full their stomachs are.

So, the point I want to make is that different parts of the world are going through different conversations. Please do not assume that this is a kind of universal phenomenon, it is not,” he said, adding, “there are parts where it is working well. Maybe there are parts where it’s not and the parts which are not, I think people need to have honest conversations about why it’s not.”

“But I would argue that to an extent, as someone dispassionately viewing it, a lot of it is an accumulated problem of the model of globalisation that we have followed for the last 25-30 years. I think a lot of chickens have come home to roost. So, yes there are issues, but from our point of view, let’s not make that universal,” he added.

Zelenskyy, Scholz stand against Trump policies

TWO TOP EUROPEAN leaders stiffened their spines Saturday over unsettling new policies from Washington under President Donald Trump, as Ukraine’s president urged creation of an “armed forces of Europe” and the leader of Germany denounced meddling in its election after US vice president JD Vance met with a German far-right leader. Strident speeches from Ukrainian President Volodymyr Zelenskyy and German Chancellor Olaf Scholz on day 2 of the Munich Security Conference testified to the impact of a blizzard of Trump decisions that have resonated at home and in Europe, notably his hopes to end the Russia-Ukraine war and nurture perceived allies on the continent.

Ramping up his desire for a more muscular and mighty Europe, Zelenskyy said Ukraine’s three-year fight against an invading Russian army has proved that a foundation exists for the creation of a European army that has long been discussed among some continental leaders.

He alluded to a conversation between Trump and Russian President Vladimir Putin, after which Trump said they would likely meet soon to negotiate a peace deal over Ukraine—breaking with the Biden administration’s harder line against Moscow over Russia’s full-scale invasion of Ukraine in 2022. Trump later assured Zelenskyy that he, too, would have a seat at the table to end the war. He insisted Europe should also have one, saying “it will never accept deals made behind our backs without its involvement and the same rule should apply to all of Europe,” Zelenskyy said.



Israel, Palestine exchange hostages

HAMAS RELEASED ISRAELI hostages Iair Horn, Sagui Dekel Chen and Sasha (Alexander) Troufanov in Gaza on Saturday and Israel freed 369 Palestinian prisoners and detainees in exchange, after mediators helped avert a ceasefire collapse. The three Israelis were led onto a stage with Palestinian Hamas militants armed with automatic rifles standing on each side of them at the site in Khan Younis, live footage showed, before they were taken into Israel by Israeli forces.

Shortly afterwards, the first bus carrying freed Palestinian prisoners and detainees departed Israel’s Ofer jail in the Israeli-occupied West Bank. The bus arrived in Ramallah to a cheering crowd, some waving Palestinian flags. “We didn’t expect to be freed, but God set us free,” said Musa Nawarwa, 70, from the West Bank town of Bethlehem, who was serving two life terms for killings of Israeli soldiers in the West Bank. He is a former commander of the Al-Aqsa Martyrs Brigades militant group. Argentina-born Iair Horn, 46, was taken captive together with his younger brother Eitan. Horn appeared to have lost considerable weight in captivity. The swap allayed growing alarm that the ceasefire agreement could unravel before the end of the 42-day first stage of the truce pact in effect since January 19.

Britain's railway celebrates 200 years with DDLJ musical

RAILWAY 200, BRITAIN’S celebration of 200 years of the modern railway network this year, has joined hands with film production company Yash Raj Films (YRF) for a unique India-UK cultural celebration and the romance associated with railways in Bollywood.

Dilwale Dulhania Le Jayenge, popular as *DDLJ* worldwide, was famously shot extensively in the UK, including a key scene at London’s King’s Cross Railway Station where the film’s lead

pair — Shah Rukh Khan and Kajol — met for the first time. Railway 200 is now planning to celebrate that connection with a set of immersive activations at Manchester and London railway stations as YRF finalises the cast for its *Come Fall in Love – The DDLJ Musical* stage premiere in May. “We’re very pleased to partner with Yash Raj Films and celebrate the enduring romance of rail and power of connection across the world,” said Suzanne Donnelly, Executive Director of Railway 200.

DDLJ has the distinction of being the longest-running title

in Indian cinema, playing continuously in Mumbai since its release back in 1995. In 2025, YRF is celebrating 30 years of one of the highest grossing Hindi films in the history of Indian cinema. “YRF has always stood for bringing stories that are rooted in India, yet have a global footprint and *Dilwale Dulhania Le Jayenge* is a testament to that,” said YRF CEO Akshay Widhani. “To celebrate 30 years of DDLJ, we are bringing the stage adaptation of the movie *Come Fall in Love – The DDLJ Musical* to the UK. Our musical is set to have its UK pre-

miere at the Manchester Opera House on May 29,” he said. “Together, we want to spread the message of how unifying love can be and how celebrating diversity and inclusivity is the need of the hour,” he added.

Come Fall in Love – The DDLJ Musical is an English language stage production directed by Aditya Chopra, the original director of *DDLJ*. Its story will be a nod to the original as it follows Simran as a young British Indian woman who finds herself engaged to a family friend in India in an arranged marriage. However, the plot thickens

when she falls in love with a British man named Roger.

The production will feature an original score, complete with 18 English songs, with music by Vishal Dadlani and Shekhar Ravjiani and lyrics by Nell Benjamin. The creative team also includes choreographer Rob Ashford, of Disney’s *Frozen* fame, with co-choreography by Shruti Merchant. UK-based actors Jena Pandya and Ashley Day have been cast as Simran and Roger for the show which had a world premiere at The Old Globe in San Diego, California, back in 2022.
